In exercise of the powers conferred upon me under Section 8 of the Customs Act, 1962 (52 of 1962), I, Shiv Kumar Sharma, Principal Commissioner of Customs, Ahmedabad, hereby approve the place as specified in column No. 1 and 2 of the below mentioned Schedule to be landing place for unloading of Imported goods and for loading of Export goods, wherein goods means: diamonds, precious and semi- precious stones, pearls, Jewellery made of gold or any other precious metal, with or without studding, industrial diamonds including powders, both natural and synthetic and synthetic stones, and also notify the area as specified in Column No. 2 and 3 of the below mentioned Schedule as Customs Area under sub-Section (a) and (b) of Section 8 of the Customs Act, 1962 (52 of 1962), with its limits as specified in Column No. 4 and 5 of the Schedule, subject to strict observation of the provisions of the said Act and instructions issued by the Government of India from time to time in pursuance thereof.

In exercise of the powers conferred upon me under Section 45(1) and 141(2) of the Customs Act, 1962, I, Shiv Kumar Sharma, Principal Commissioner of Customs, Ahmedabad, hereby appoint "M/s. SDB Diamond Bourse" to be the custodian of the Imported goods namely, diamonds, precious and semi- precious stones, pearls, Jewellery made of gold or any other precious metal, with or without studding, industrial diamonds including powders, both natural and synthetic and synthetic stones; received at the Air Freight Station (AFS), Surat located at Upper Basement, Diamond Club, Block No. 177/P, Khajod, Near Sarsana Convention Centre, Hazira-Sachin Highway, Surat 395007 Gujarat, until these are cleared for home consumption, or are warehoused, or are transshipped in accordance with the provisions of Chapter VII and VIII of the Customs Act, 1962, and of the Export cargo brought into said Air Freight Station for examination and stuffing, till their exportation.

2. Further, in exercise of the powers conferred upon me under Regulation 10 of the 'Handling of Cargo in Customs Areas Regulations, 2009', I, Shiv Kumar Sharma, Principal Commissioner of Customs, Ahmedabad approve "M/s. SDB Diamond Bourse" as the 'Customs Cargo Service Provider' for the entire Customs Area of Air Freight Station (AFS), Surat located at Upper Basement, Diamond Club, Block No. 177/P, Khajod, Near Sarsana Convention Centre, Hazira-Sachin Highway, Surat 395007 Gujarat, subject to interalia the following conditions:

- i. The Custodian, "M/s. SDB Diamond Bourse" approved as Customs Cargo Service Provider for the said AFS, Surat shall abide by all the provisions of the Customs Act, 1962 and the Regulations & conditions of the 'Handling of Cargo in Customs Areas Regulations, 2009', other Regulations, Notifications, Orders issued thereunder and they will strictly follow all Instructions / Rules / Regulations / Circulars/ Public Notices

- issued by the CBIC / Principal Commissioner of Customs from time to time in this regard.
- ii. The duration of the appointment of "M/s. SDB Diamond Bourse" as 'Custodian' and as 'Customs Cargo Service Provider' shall remain valid for **two years** from the date of Notification unless otherwise suspended / revoked / cancelled prior to the expiry of the said period.
 - iii. The Principal Commissioner / Commissioner of Customs, Ahmedabad, shall have the right to review the appointment of "M/s. SDB Diamond Bourse" as 'Custodian' and / or as 'Customs Cargo Service Provider' before the completion of two years for failure to comply with the provisions of the Customs Act, 1962 in general and / or of 'Handling of Cargo in Customs Areas Regulations, 2009' in particular.
 - iv. "M/s. SDB Diamond Bourse" shall ensure payment of Cost Recovery Charges, as applicable, in-time as per HCCAR, 2009 in terms of CRB Order No. 14/2023 (Creation of posts) dated 03.10.2023, issued by DGHRD.
 - v. "M/s. SDB Diamond Bourse" shall ensure that application for renewal of CCSP is filed well in advance, however not later than sixty days before the expiry of validity of CCSP approval.
 - vi. "M/s. SDB Diamond Bourse" shall strictly ensure that there are no blind spots left in the notified customs area without the proper coverage of CCTV, which can be misused by any unscrupulous elements resulting in contravention of the Customs Act, 1962 and Rules/Regulations/Procedures made thereunder.
 - vii. "M/s. SDB Diamond Bourse" shall ensure safety and security of the Customs area and goods stored therein. The entire handling of Imported/Export cargo shall be carried out under the coverage under 24x7 CCTV network with night vision covering entire area having minimum capability to record & hold data for three month in the Customs area.
