All such representations should be forwarded through proper channel with specific comments/recommendation of the jurisdictional Pr. Commissioner/Commissioner.
5. All the officers may be relieved on or before 02.08.2024 to join their new place of posting. Date of relieving and joining of the officers may be intimated to this office promptly. Officers who are under order of transfer from CGST Zones and have joined CCO Ahmedabad Customs Zone during the transition period hereby stand relieved immediately.

7. The Principal Commissioners/Commissioners are requested to ensure that officers relieved should give a proper handing over note to his successor/officer taking over her/his charge.
