2. Reasonable care has been taken to indicate the present place of posting of officer(s). 6. All of the above promotions are ordered without prejudice to the claims of other officers, who at later stage may be found to have prior claims over the said officers in the matter of promotion to the grade of Superintendent Group "B" of CGST & CE.

7. If any of the officer promoted as per this Order has been granted the financial benefit under the ACP / MACP Scheme in the GP of Rs.4,800 (pre-revised scale) prior to this promotion, no pay fixation benefit shall accrue to him or her now on account of this promotion, in terms of the provisions contained in Modified Assured Career Progression Scheme introduced by Government of India, Department of Personnel & Training's O.M.No.35034/3/2008-Estt.(D) dated 19.05.2009.
