ADDENDUM TO THE PUBLIC NOTICE NO. 26 /2020-21

Subject:- Notification of FSSAI's Authorized Officer for Mundra Port under Section 47(5) of FSS Act, 2006-reg.

Attention of the members of Trade is invited to the Public Notice No. 26/2020-21 dated 09.11.2020 of this Commissionerate notifying authorized officers of Customs in terms of provisions contained in Section 25 read with Section 47(5) of FSS Act, 2006 in pursuance to Order issued by the Chief Executive Officer, Food Safety and Standards Authority of India, New Delhi vide F. No. 1-1371/FSSAI/Imports/2015 dated 29.03.2016. The para 2 of the said Public Notice needs to be amended so as to include the Old Port Mundra.
