NOTICE INVITING TENDER

The office of Principal Commissioner of Customs, Customs House, Mundra Port, Kutch, Gujarat invites sealed tender/quotation from authorized recyclers/processors possessing valid registration/authorisation from the GPCB/CPCB/SPCB and other applicable statutory authorities, for disposal/recovery/recycling of the confiscated Aluminium Dross detailed below. The details of the goods to be disposed of are as under:-

Interested bidders have to submit their bid in sealed cover in the prescribed format as per Annexure-A, along with the requisite documents, on or before 25.08.2026 till 5:30 PM. The bids received will be opened on 26.08.2026, in the office of the Assistant Commissioner of Customs (Disposal), Custom House, Mundra, in the presence of independent witness(es).

Note:

1. All the sealed tenders shall be super-scribed with the details given below, and tenders that are not so super-scribed are liable to rejection without opening. Sealed tender for lot no. ('item name' can also be given but not necessary.)
2. No bid shall be made through email. Any bidder who submits a bid through email shall not be considered in the tendering process, irrespective of whether the same bid has been submitted by sealed tender or not. Only sealed tenders have to be submitted within the time and date specified.

Eligibility / Documents to be furnished by Bidders:-

Since the confiscated goods comprise Aluminium Dross, an item restricted for import under the Foreign Trade Policy/DGFT regulations, and its handling/recycling is governed by the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016, participating bidders shall be required to furnish documentary evidence of all applicable approvals, registrations and authorisations, including, wherever applicable:

- Valid authorisation/licence for import/procurement, handling, processing, recycling and recovery of aluminium dross/aluminium-bearing waste, as required under the Foreign Trade Policy/DGFT regulations and other relevant statutory provisions;
- A valid passbook/record maintained by the concerned competent authority, wherever applicable, in respect of recycling/utilisation of aluminium-bearing waste generated during manufacturing/recycling operations, as required under the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016, as amended; and
- A valid Consent/Authorisation/Registration issued by the Gujarat Pollution Control Board (GPCB), Central Pollution Control Board (CPCB) or the concerned State Pollution Control Board (SPCB), as applicable, authorising the bidder to handle, process, recycle and/or recover aluminium dross/aluminium-bearing waste.

Only those bidders who possess all applicable statutory approvals, and whose authorisations are valid on the date of submission of the tender and date of delivery, shall be considered eligible for participation in the tender process. The successful bidder shall furnish an Undertaking declaring that the Aluminium Dross

shall be utilised solely at its authorised facility for recovery/recycling/processing of aluminium and other recoverable materials, and shall not be sold, transferred or diverted to any unauthorised person or entity.

Terms and Conditions

1. The goods can be inspected at Saurashtra CFS, Mundra on prior appointment.
2. The tender shall be on 'As is where is basis'.
3. Bids received within the due date & time only will be entertained.
4. Bidders cannot withdraw their offer once it is submitted.
5. It is the responsibility of the bidder to assess the goods properly before quoting the rate. No further claims will be entertained after opening of the bids.
6. GST at applicable rate will also be applicable on the bid amount.
7. All applicable taxes and duties shall be extra, which will be paid by the tenderer/bidder at the time of delivery of the materials.
8. The successful bidder has to pay the entire amount within 03 days on receipt of the acceptance letter of the department.
9. No enquiry of bidders shall be entertained once the material is lifted by them.
10. This office also reserves the right to accept/reject the offer or cancel the whole tender proceedings without assigning any reason. The decision of this office will be final and binding on the bidder(s).
