**Subject: Waiver of Late filing Charges, Detention & Demurrage Charges
charged by Container Freight Stations, Port Terminals & Shipping
Lines: m/reg.**

Attention of all Importers/Exporters, Customs Brokers, CFSs, Custodians, all other Stakeholders and all taxpayers is invited towards the Adani Port and logistics Trade Notice of **Weather Advisory dated 29.08.2024** informing suspension of all the operations in the Port from 27.08.2024 due to deep Depression over Saurashtra and Kutch and accordingly the Port Authority has put on hold all operations in terms of Cargo Vehicles movements through Port Gates and at SEZ Gates w.e.f. 27.08.2024.

2. Due to this aforesaid directions and natural calamity, empty or loaded containers were not moved to their designated places and port operations were normalized only on **31.08.2024**. Further, due to disruption in the electricity and internet all work related to documentation was on hold till **30.08.2024 & resumed thereafter**.

3. In view of the above, all CFSs, Shipping Lines and Terminals are requested to examine favorably requests from the Trade on waiver of Charges for the period of **28.08.2024 to 31.08.2024**. Further, it has been decided that "Late Fee" imposed for delayed filing due to incessant rains due to the Depression over Saurashtra and Kutch and consequent disruption of Port Activities is hereby waived off in respect of Bills of Entry filed belatedly, which pertains to the Containers/vessels which got entry inward from **28.08.2024 to 31.08.2024** subject to production of evidentiary documents in this regard.

4. Difficulties, if any, faced in the implementation of this Public Notice may be brought to the notice of the Additional Commissioner of Customs through email at commr-cusmundra@nic.in.

5. This Public Notice should be considered as a Standing Order for the purpose of the Officers and Staff of Customs House Mundra.
