PUBLIC NOTICE No. 17/2026

Subject: Adoption of procedures/practices followed by Jawaharlal Nehru Custom House (JNCH) for bringing uniformity in Customs procedures – reg.

Attention of all Importers, Exporters, Customs Brokers, Shipping Lines, Terminal Operators, Custodians and other stakeholders is invited to the various Public Notices, Standing Orders, Trade Notices, Office Orders and other instructions issued by the Jawaharlal Nehru Custom House (JNCH) from time to time prescribing procedures for facilitating Customs clearance and promoting uniformity in Customs processes.

2. In this regard, the Central Board of Indirect Taxes and Customs (CBIC), vide communication F. No. 450/41/2005-Cus-IV dated 17.07.2026, has, inter alia, observed that the processes adopted by JNCH through its Public Notices, Standing Orders, Trade Notices, Office Orders and other instructions can serve as a model for other ports and has directed adoption of JNCH processes with a view to bringing uniformity at the all-India level.

3. Accordingly, with a view to ensuring uniformity and consistency in Customs procedures, the procedures/practices followed by JNCH shall, mutatis mutandis, be followed at Mundra Customs also unless the same is necessitated by a specific requirement peculiar to Mundra Customs, including any infrastructural or geographical constraint.

4. All stakeholders are requested to bring to notice of the undersigned any process which in their opinion is not in sync with JNCH's documented process so that it may be examined for taking appropriate action.

5. This issues with the approval of the Commissioner, Mundra Customs.
