As per Guideline issued by Ministry of Road, Transport & Highways (MoRTH), New Delhi vide Notification No. RT-23013/01/2018-T dated 24th

October, 2019 and Office Memorandum vide F.No. 01(18)/2022-E.II(A) dated 09.12.2022 issued by Deputy Secretary, Department of Expenditure, Ministry of Finance, Govt. vehicles which have been declared condemned shall only be scrapped at RVSF (Registered Vehicle Scrapping Facility) Centers.

Only those vendors which are registered as the Registered Vehicle Scrapping Facility (RVSF) under the guidelines of Ministry of Road Transport and National Highways can take part in the bidding. Bidders from all over India registered under RVSF are invited to take part in bidding. All such eligible bidders are required to attach their RVSF registration details, credential etc.

The delivery of the old, un-repairable, obsolete, unserviceable or condemned vehicles will be made to the successful bidder only after submitting demand draft of full amount. If the bidder fails to submit the demand draft of full amount within seven (07) days, department may reject the bid of the successful bidder and have the right to re-auction the said items. The bids will be opened on 23.03.2026 at 12:30 PM.

The rates quoted by the bidders for purchase of old condemned vehicles will be all inclusive and on "As is where is basis". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicles on a date and Time specified by this office and will arrange for transportation of the same on that day at his expense.

The vehicles will be disposed off on the basis of highest rate. However this office reserves the right to withdraw the vehicles from the bidding process in case the quoted price received is less than the reasonable market price.

The selected bidders will have to submit 'Certificate of Deposit' and 'Certificate of Vehicle Scrapping' to this office.

This office reserves the right to reject any or all the bids without assigning any reasons.
