PUBLIC NOTICE NO. 24/2025-26

Subject: Conduct of Additional CBLR Regulation 6 (F-Category) Examination, 2025 – reg.

It is hereby brought to the notice of all concerned that an **Additional Written Examination** for the Customs Brokers Licensing Examination, 2025, under Regulation 6 of the Customs Brokers Licensing Regulations (CBLR), 2018 (as amended), will be conducted, as a special measure, on 16.12.2025 at designated examination centres across India.

2. The examination will be conducted in **Computer-Based Test (CBT)** mode and will consist of **150 Multiple Choice Questions (MCQs)** to be answered within **2½ hours (10:30 hrs to 13:00 hrs)**. The total marks for the written examination will be **450**, with a prescribed marking scheme of +3 for each correct answer and –1 for each incorrect answer. The minimum qualifying marks are **270 (60%)**. Candidates qualifying in the written examination shall be required to appear for the subsequent oral examination, for which separate communication will be issued by NACIN. Questions will be **bilingual, presented in both English and Hindi**

3. The syllabus shall remain the same as prescribed under Regulation 6(7) of the CBLR, 2018. Candidates qualifying the written examination shall be required to appear for the oral examination. Successful candidates will be called for an oral examination for which separate communication will be sent. The oral examination will be held during the calendar year 2025. The pass percentage marks for qualifying in the oral examination will be 60%.

4. Only those candidates who were **shortlisted for the CBLR Examination, 2025 (whether they actually appeared in the written examination or not)** are eligible to appear for this Additional examination. No fresh application will be invited, and candidates who have already been selected in the final results of the CBLR Examination, 2025, shall retain their selection and are not required to appear again.

5. For the purposes of Regulation 6(4) of the CBLR, 2018, the CBLR Examination, 2025 and the additional examination, 2025 shall together be treated as a single attempt.

6. A consolidated **list of eligible candidates** pertaining to the jurisdiction of Policy Commissionerate – Mundra Customs, who were short- listed for appearing in the examination, is enclosed herewith

as **Annexure-A** for ready reference. This Public Notice will also be emailed to the registered email IDs of the eligible candidates, and they are advised to verify their particulars and ensure their readiness for the examination.

7. Candidates are informed that, as part of the examination process, their photograph must be submitted as a separate digital file to "ag-mundra@gov.in". The file name must be saved strictly as the candidate's PAN number to ensure correct identification and processing. For example, if the candidate's PAN is ABCDE1234F, the photograph should be saved as ABCDE1234F.jpg (or ABCDE1234F.jpeg / ABCDE1234F.png , as applicable). Submissions in any other format or in hard copy will not be accepted.

8. Admit Cards will be made available well before the examination date on www.nacin.gov.in under Examination→ Customs Broker → Practice Test. Candidates will also be informed by email. A dummy test paper will also be hosted on the same portal.
