3. All the representations received regarding transfers/retention stands disposed off. No further representations whosoever will be entertained until the officers join at their new place of posting

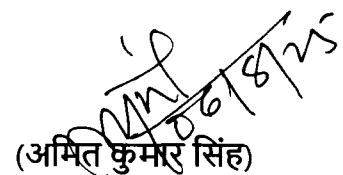
