FACILITY CIRCULAR NO. 03/2024**Subject: Export of Parboiled Rice (CTH: 10063010) – reg.**

Attention of all Exporters, Customs Brokers (CBs), Trade Members and Other stakeholders is invited to the CBIC Notification No. 46/2024- Customs dated 22.10.2024 wherein the export duty prescribed against the sl.no. 6A, 6B & 6C as mentioned in the CBIC Notification No. 27/2011- Customs dated 01.03.2011 has been removed. Subsequently, the DGFT, vide Notification No. 37/2024-25 dated 23.10.2024 has amended the export policy of Non-Basmati Rice falling under HS Code 1006 30 90 to 'FREE' by removing the Minimum Export Price @USD 490/tonne.

2. After the CBIC Notification No. 46/2024-Customs dated 22.10.2024, references have been received from the Exim Trade regarding the current procedure for drawing of samples for testing and the provisional release of the consignments for export, with a bond, for goods declared as '**Parboiled Rice**' under **CTH: 10063010** at the time of export.

3. The matter has been examined by this office and it has been decided that drawal of sample and submission of a bond for goods declared as 'Parboiled Rice' under CTH: 10063010, is no longer required, until further orders. However, RMS instructions are to be followed scrupulously.

4. Difficulty faced if any in implementation of this Facility Circular may be brought to the notice of the Principal Commissioner of Customs, Customs House, Mundra.
