The aforementioned examination is scheduled **to be held on 17.03.2026**. The Pattern of the written and oral examination will be as follows.

2. The written examination will be a Computer Based Examination with Multiple Choice Questions. Questions will be bilingual i.e. in English and Hindi. Candidates have the option to answer either in English or Hindi. Other details are as follows:

Maximum Marks:	450
Qualifying Marks:	270 (60%)

3. Those qualifying in the written examination will have to appear in oral

examination in terms of Regulation 6 of the Customs Brokers Licensing Regulations, 2018, as amended. **The pass percentage marks for qualifying in the oral examination will be 60%.**
