Ltd. as the Custodian shall comply with **all the relevant provisions of the Customs Act, 1962 read with Handling of Cargo in Customs Areas Regulations, 2009 (HCCAR, 2009), as amended and all applicable rules, regulations, notifications, circulars, instructions, and other laws governing for the operation of said CFS.**

3. The appointment shall remain valid for an initial period of two years, subject to satisfactory performance. The Commissioner of Customs, Kandla may suspend or revoke the approval for violation of any provision of the Act, rules, regulations, notifications, or orders issued thereunder and also terminate the appointment after recording reasons and providing an opportunity of being heard. The appointment shall be reviewed after two years from the date of issue of this Notification.
