With reference to the SCN dated 24.06.2024 and supplementary SCN dated 20.06.2025, issued in respect of M/s Rudhra Impex (IEC No.0316511480), Mumbai, by the Commissioner of Customs NS III, JNCH, Nhava Sheva, a further Corrigendum dated 20.06.2025 to aforesaid SCNs, has been issued by the Commissioner of Customs, Nhava Sheva-III (JNCH), wherein the Adjudicating authority has now been changed to Commissioner of Customs, Mundra Port, in terms of Notification No. 28/2022-Customs (N.T.) dated 31.03.2022, being the Port with highest duty liability.
