- No bid shall be made through email. Any bidder who submits a bid through email shall not be considered in the tendering process, irrespective of whether the same bid has been submitted by sealed tender or not. Only sealed tenders have to be submitted within the time and date specified.

- The tender shall be on 'As is where is basis'.

3. Bids received within the due date only will be entertained.
4. Bidders cannot withdraw their offer once it is submitted.

6. GST at applicable rate shall also be applicable.
