**CORRIGENDUM TO ORDER-IN-ORIGINAL**

**Subject: - Order-in-Original No. MUN-CUSTM-000-COM-014-25-26 dated 22.07.2025 issued by the Commissioner of Customs, Custom House, Mundra in case of M/s Jindal Trading Co., (IEC-3015900749) – Reg.**

In exercise of powers conferred upon me under Section 154 of the Customs Act, 1962, due to clerical oversight occurring in the Order-in-Original No. MUN-CUSTM-000-COM-014-25-26 dated 22.07.2025, in case of M/s Jindal Trading Co., Punjab (IEC-3015900749), the following shall be substituted:

**In the said O-I-O, Part (i) of Para 20.16, ORDER Portion -**

**"i. I hold the subject goods 1802.5 MTs of PVC Resin (as mentioned in Table-2) having assessable value of Rs. 11,34,02,322/- imported duty free under Notification no. 18/2015-Customs dated 01.04.2015, as amended, liable to confiscation under Section 111(o) of the Customs Act, 1962, for violation of the conditions laid down under the said Notification. Further, in terms of conditions of bond executed by the Importer with the DGFT authorities, I impose a redemption fine of Rs.1,00,00,000/- (Rupees One Crores Only) as the subject goods are not physically available, I refrain from imposing any redemption fine in the matter;**

**"i.
